Please note we will be holding the trial on Saturday and Sunday following the Kansas stakes. Also please note that our Puppy stake will not be held prior to the conclusion of the 2<sup>nd</sup> series of Amateur stakes.

All - age Judges will be **Randy Curtis** and **Bob Ryan**. Puppy judges will be announced with the running order.

The trial is planned to be held at Springer Hollow located 4 ½ miles west of Spivey and 1-1/10th miles north on SW 70<sup>th</sup> Avenue.

There can be absolutely **NO SMOKING** anywhere on the grounds - that even includes the parking lot.

Lunches will be available. The banquet will be Saturday evening (more information later). There will be no formal training session.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold the AKC, the event giving club, their members, directors, governors, officers, agents superintendents or show secretary and the owner or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. 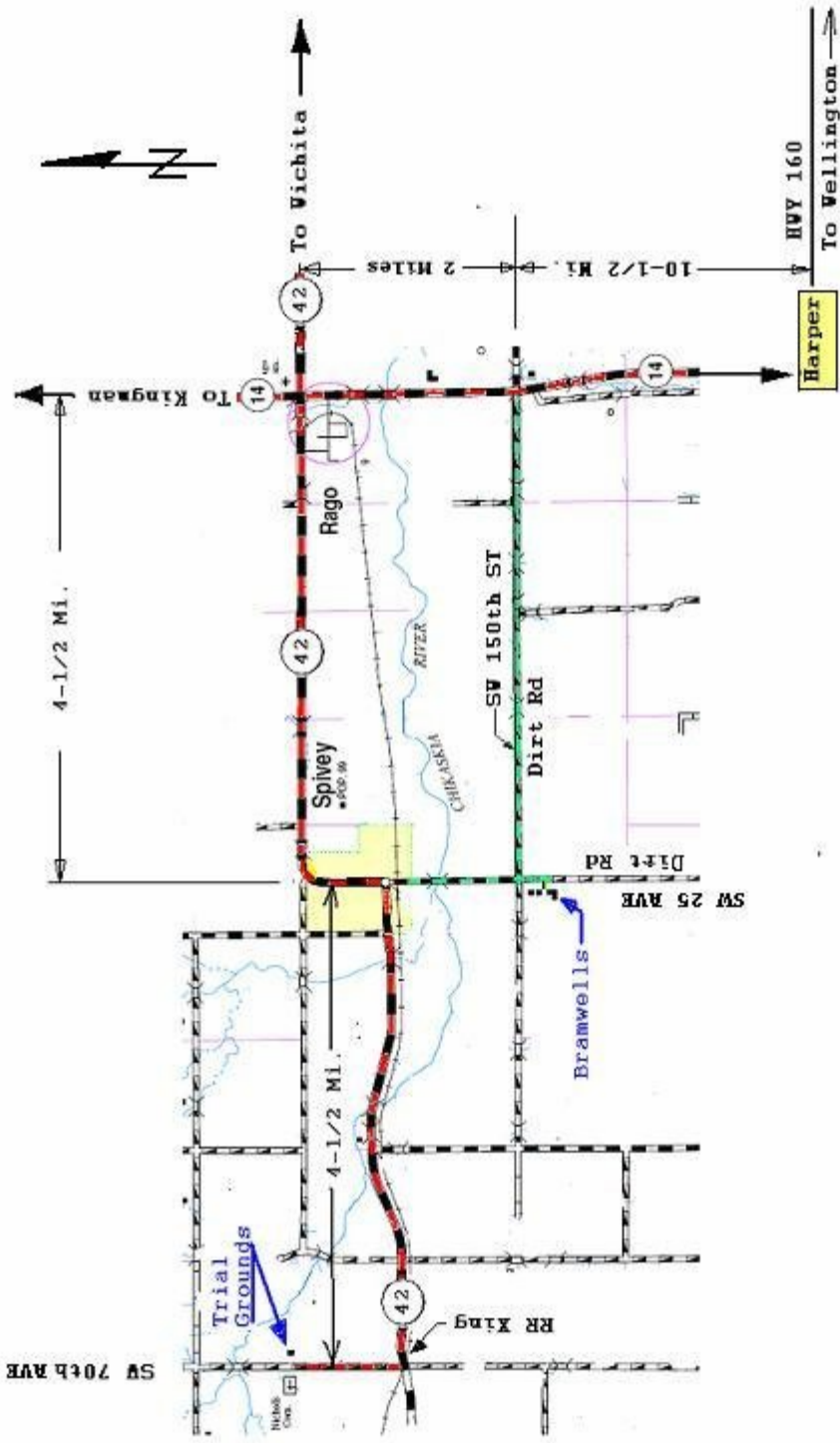
