Field trial headquarters will be the Gridley Inn and RV Park. The RV park offers full hookups. A block of rooms will be held at the motel until February 26, so please call early for your reservation, (530) 846-4520. Other "pet friendly hotels" are the Econo Lodge (530-674-1592) and the Days Inn (530- 674-1711) in Yuba City and America's Best Value Inn and Suites (530-533-7070) in Oroville.

Our banquet and raffle will be Saturday night. The no host bar opens at 6:30 PM with dinner at 7:00 PM at the Moose Hall located across the street from headquarters. Entrees this year are \$25.00 for either shrimp scampi or prime rib, selection to be noted on your reservation form. The Gridley Moose has asked for our order selections by February 25th. Awards for Amateur and Puppy Stakes will be presented at our banquet; Open Stake awards will be presented at the grounds following Sunday's event.
