- *Take Exit 1 for Industrial Park Rd
- *Turn left at Industrial Park Rd
- *Turn right at ME-112/North St. Continue to follow Me-112 for approx 13.5 miles
- *Turn left at W Buxton Rd
- *Continue on Moderation St
- *Turn left at ME-35/River Rd
- *Slight right at High St
- *Turn right at Decker lane(circle)
- *Arrive at grounds

Directions coming south to Trial Grounds

- *Take Exit 42 off the Maine Turnpike(Scarborough)
