CONDITIONS FOR ENTRIES:

Puppies: Any AKC registered English Springer Spaniel that has not reached its
second birthday on the first day of the trial.

Amateur All Age: For any Amateur handle and any AKC registered English Springer
Spaniel over six months of age.

Open All Age: For any AKC registered Springer Spaniel over six months of age.

Note:

- A separate entry form must be submitted for each dog entered and
for each Stake entered.
- Training on Field Trial Grounds on the days of the events is not
allowed.
- Smoking is allowed **only** in the parking area *not* in the field.
- Bitches in heat are prohibited on the grounds.
- Any and all dogs must be kept on leash until called to the line.
