We are adding an Amateur stake this year, and combined with the Tamarin Spaniel Club trial, are planning four days of competition at Gray Lodge Wildlife Area, Sutter Buttes, CA.

Open and Amateur Judges: Pete Rainey of Minnesota and Jan Johnson of Oregon.
Puppy Judges: Kris Golomb and Ron Anderson both of California.

Awards for all stakes will be presented on the grounds following the events both days.

Motel: Field trial headquarters is the Gridley Inn, 1490 Highway 99, Gridley, CA - 877-846-4520. The other motel in Gridley is the Pacific Motel 530-846-4580. Both motels are on Hwy 99 at the south-end of town.

Directions to the grounds from motels: Go north on Hwy 99; turn left onto Sycamore (Colusa Hwy) go approx. 6 mi.; turn left onto Pennington Rd., go approx. 3 mi. to Gray Lodge Wildlife Refuge check-in parking lot on your right.

Lunches will be available on the grounds for a fee.

There will not be a training day.

Blaze Orange is required to be worn above the waist by all participants and observers. Protective eyewear is recommended for everyone on the grounds.

Note: Excused scratches for bitches in season. All other reasons to be determined at the discretion of the field trial committee.
