### **Directions to the Hunt Test Site:**

#### *From Cedartown:*

South of Cedartown at the junction of Bus 27 and US 27, go north 1/4 mile on US Cason Rd. Turn right and go 4.3 miles to JL Lester which is on the right side of the road (just past Antioch Community sign). Cason Rd changes names to Antioch Rd.

#### *From Atlanta:*

I-20 West toward Birmingham (travel approximately 40 miles). Take Exit 11 toward Breman, turn right from exit, onto US 27 North. (go 19.7 miles). Turn right onto Youngs Farm Rd. (do not drive over the RR track at high speed or you will bottom out). At dead end, turn right onto Antioch Rd (also known as Cason Rd). Look for JL Lester WMA on right (just past Antioch Community sign).
