Spaniels are flushing breeds. Their purpose is to hunt, find game, flush and retrieve birds in a pleasing and efficient manner. The objective of the hunting test program is to help a hunter develop a useful hunting companion by providing a means to gauge a dog's ability against three standards of accomplishment – Junior Hunter, Senior Hunter and Master Hunter.

Ethics and good sportsmanship require the hunter to dispatch the game as quickly and humanely as possible. Sportsmanship also demands the retrieval of all shot game. To this end these dogs are trained.

The group of spectators following the dogs afield is the gallery, and leading the gallery is the Field Marshall. As live ammunition is used in the Spaniel Hunt tests, it is imperative to listen to the Field Marshall's instructions.

Please do not make any unnecessary noise while in the gallery, especially while the dogs are working the field. All dogs entered must be on a leash when not running. An item of blaze orange clothing (no less than a blaze orange hat) is required to be worn at all times by participants and spectators.
