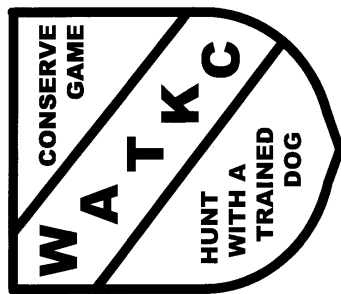

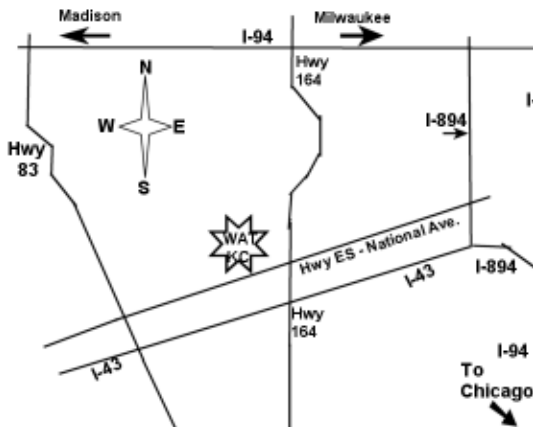

AGREEMENT
