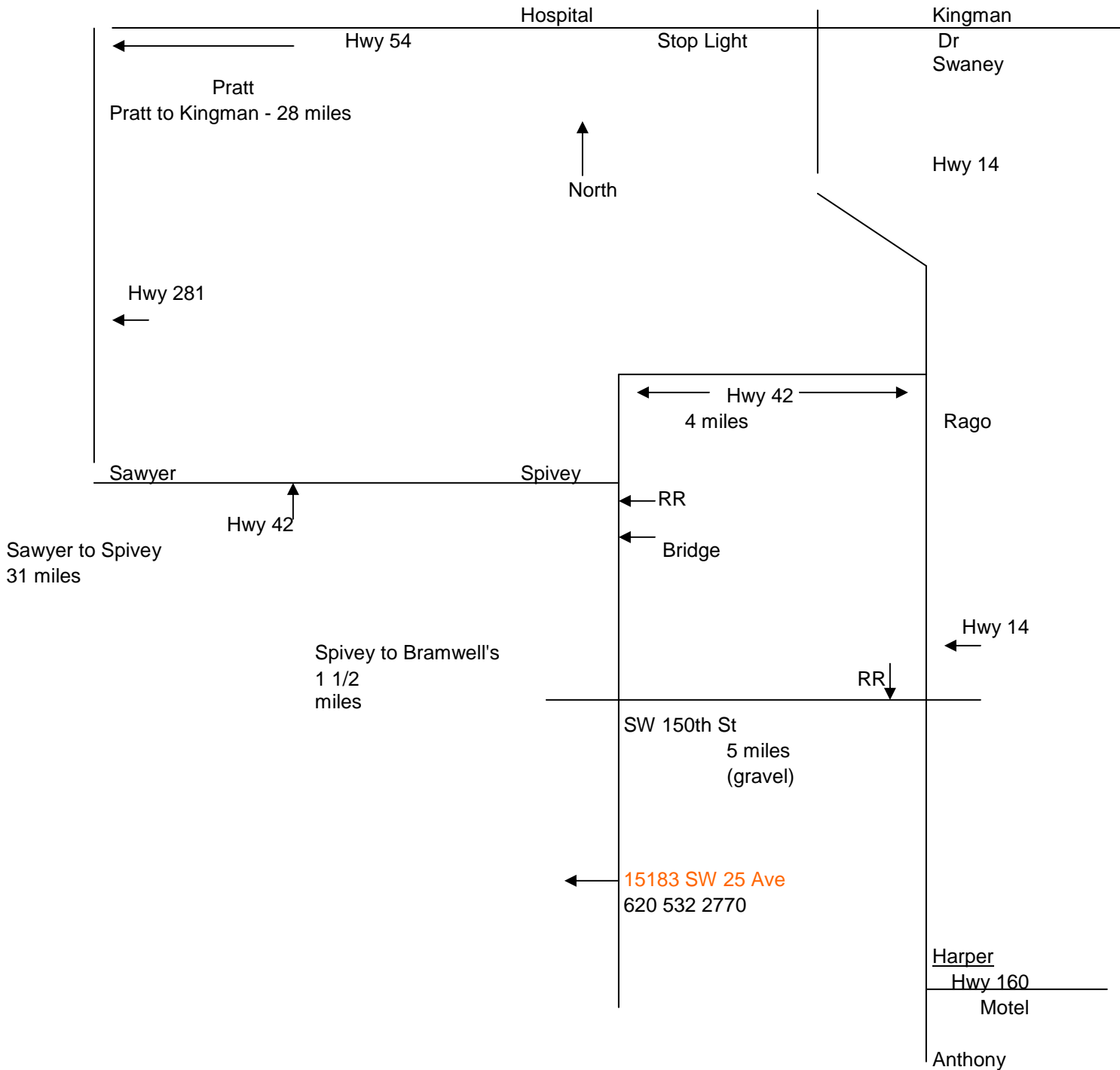

Directions: From Wichita – take Hwy 54 west to Kingman (approx 40 miles). In Kingman, take Hwy 14 South to Hwy 42 (approx 15 miles). Take Hwy 42 West into Spivey (the road will curve south). Here Hwy 42 turns west toward Zenda. Do NOT take this west curve but continue south. There is Jayhawk Oilfield Supply on the southeast corner that you will pass, then a RR track & go over a bridge. You will continue south for approx 1 ½ miles. At the top of the hill, the road changes to dirt. If it is wet, please be careful as the road is slippery. Our house is approx ¼ mile from the dirt road on the west side. Looking forward to seeing you.
