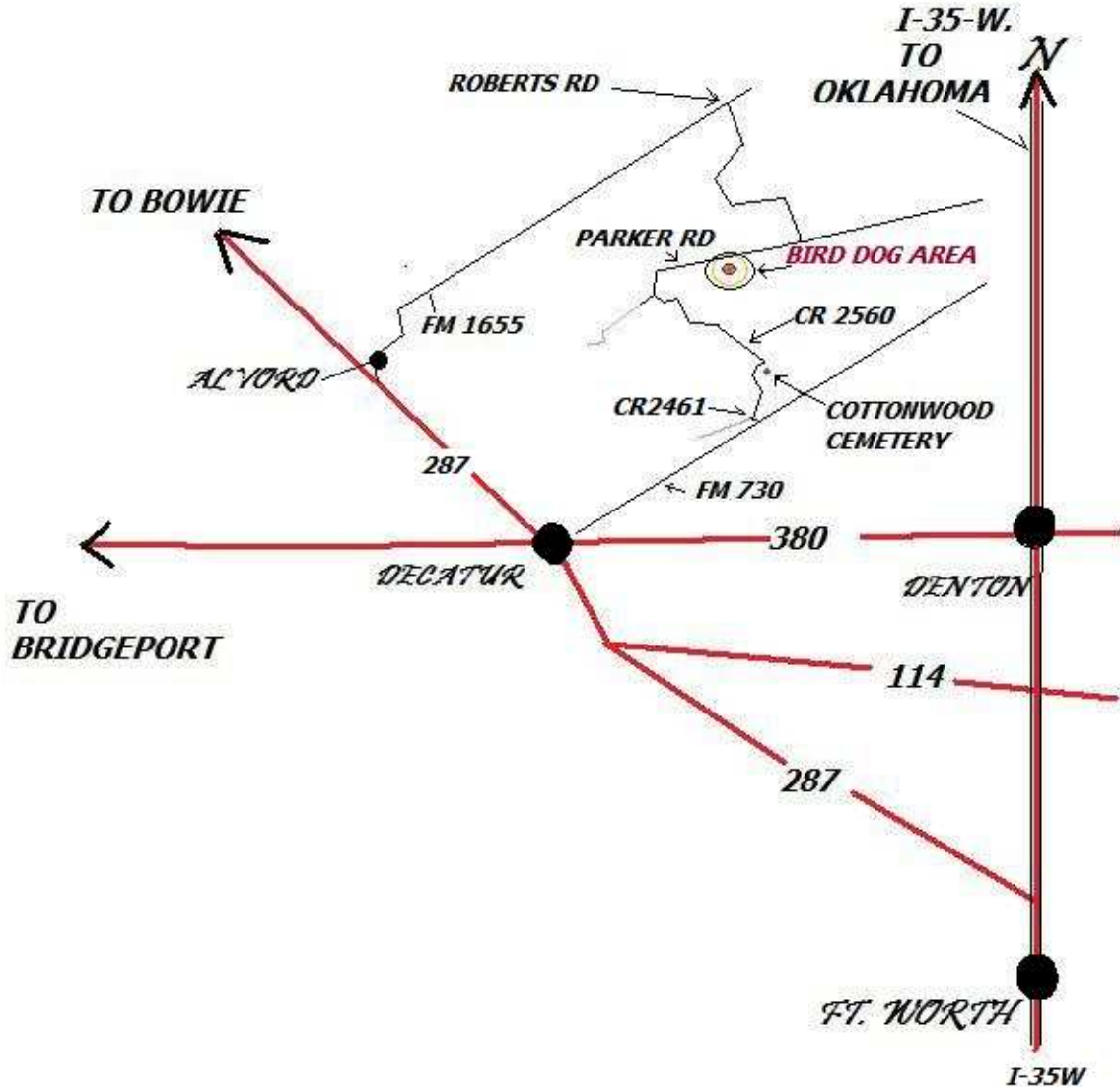
Directions

From hotels go north on HWY 287 a couple of miles to the EAST HWY 380 exit, you will circle around on exit ramp and "T" into Hwy 380 turn Left, the first exit is FM 730, it is on the left, when the exit ramp "T"s into 730 turn left or north, follow FM 730 north from Decatur for 9 miles and turn left on CR 2461 (Cottonwood Cemetery Road) (look for signs); at the fork (50 yds), turn right on CR 2560 for 6 miles and turn right on CR 2675 for 1 mile look for NTSSC signs.

OR

Follow U.S. Highway 81/287 north 11 miles to intersection with FM 1655 in Alvord; turn right and go 8 miles and cross Montague County Line; go ½ mile and turn right on Roberts Road. Follow Roberts and turn left on CR 2690 for 1 mile and turn right on Parker Dairy Road at about 1 and 1/2 miles look for gate on right look for NTSSC signs and flags.
