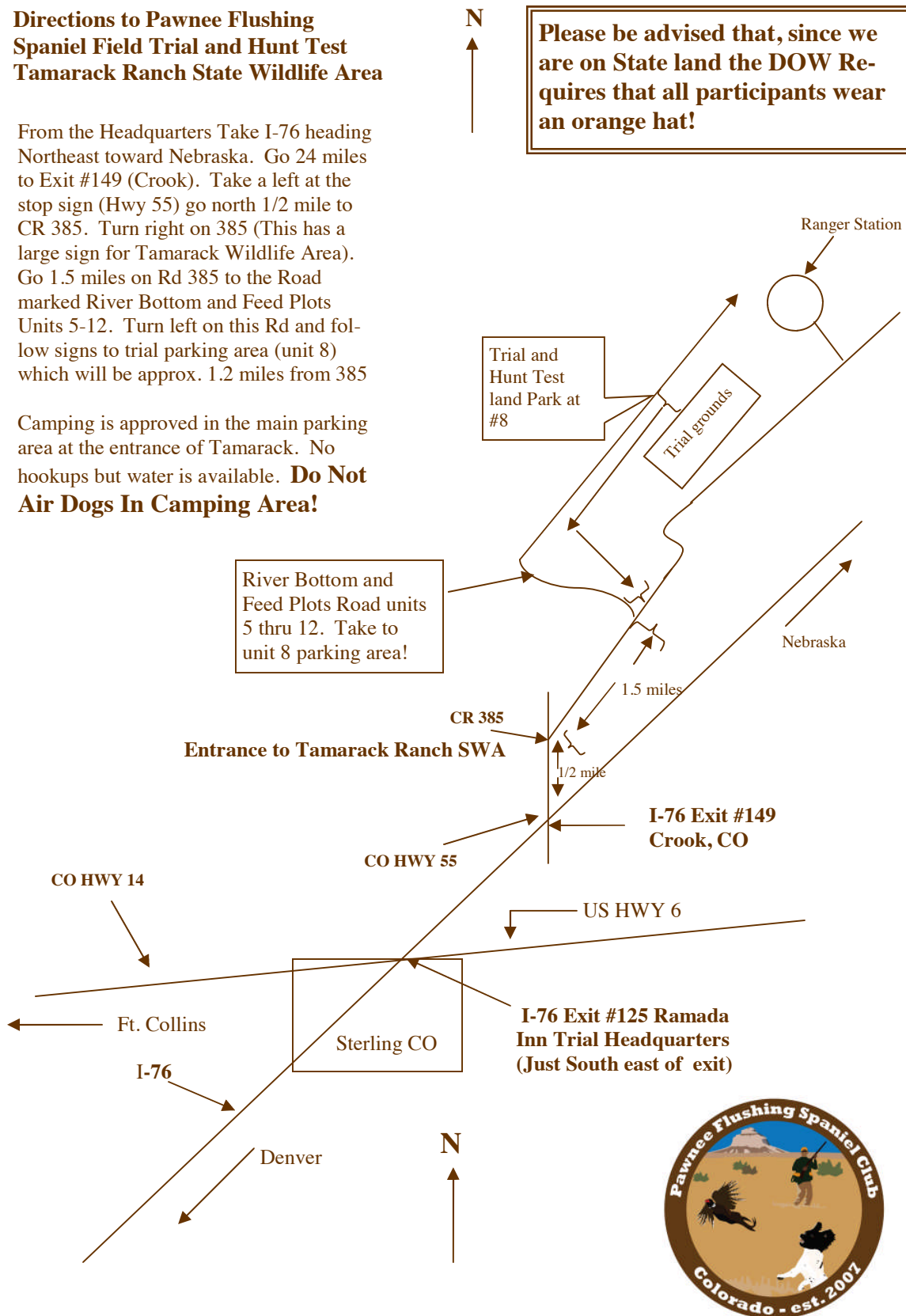

## Directions to Pawnee Flushing Spaniel Field Trial and Hunt Test Tamarack Ranch State Wildlife Area

From the Headquarters Take I-76 heading Northeast toward Nebraska. Go 24 miles to Exit #149 (Crook). Take a left at the stop sign (Hwy 55) go north 1/2 mile to CR 385. Turn right on 385 (This has a large sign for Tamarack Wildlife Area). Go 1.5 miles on Rd 385 to the Road marked River Bottom and Feed Plots Road Units 5-12. Turn left on this Rd and follow signs to trial parking area (unit 8) which will be approx. 1.2 miles from 385

Camping is approved in the main parking area at the entrance of Tamarack. No hookups but water is available. **Do Not Air Dogs In Camping Area!**
